Terms and Conditions

Deposit and Refund Policy: A non-refundable hunt deposit of 35% is required at the time of booking. The deposit is not applicable to State issued licenses and tag fees. Refunds for licenses/tags should be taken up with State License Agencies. A signed contract and deposit received will reserve the hunt dates. **The hunt balance is due on August 1 in the calendar year of your hunt.** Funds paid are non-refundable, but may be transferred at the discretion of Rafter C. Under certain circumstances, or if an emergency exists, we will apply funds to another hunt the following season. Deposits on Wyoming hunts may be transferred to a hunt offered by Rafter C Guide and Outfitting, LLC in Idaho, if client desires.

Hunt Information: Guided hunts include one guide for two hunters, except when hunter chooses a one on one hunt for an additional cost. Meals included are breakfast, lunch, and dinner provided by a camp cook, in the cook tent. Lodging is provided in wall tents, wood stoves, cots, pads, portable shower and toilet outhouse. Hunt includes trophy care of heads, and meat packing, and transportation of meat to processor. Our guided hunts are conducted using horses and pack stock. Hunts do not include cost of meat processing, taxidermy, alcohol, and transportation from your home to trailhead.

Physical Ability: Our hunts require stamina and good physical condition. We will try and accommodate all level of hunters during your hunt with us. The altitudes we hunt are between 6000' and 9000' making the air much thinner than sea level conditions. The weather can vary greatly over a short period of time, and extreme weather conditions are not uncommon during a 7 day hunt. Each hunter must recognize these possibilities, and acknowledges that they are in good health and good condition enough to participate in these hunts. We consistently take a wide range of clients of different ages and abilities, and will adjust as needed to make your hunt a positive experience. Please let us know at booking of any special needs that you may require during the hunt.

Weapons and Safety: Hunting requires use of weapons that if not used properly may inflict harm. Hunter agrees to using weapons in a safe manner during the hunt and accepts the risk that may come with such use. Each hunter agrees to abide by all State and Federal Laws, including Fish and Game laws in Idaho, and/or

Wyoming at all times and will not engage in any conduct that may subject Rafter C Guide and Outfitting, LLC and its employees, guides, or clients to investigation or prosecution. This includes illegal use, or abuse of drugs and alcohol.

Other: Rafter C Guide and Outfitting, LLC will strive to provide a quality hunt experience for each client. However, we cannot and do not guarantee good weather, successful harvest of game, or trophy harvest. The hunter acknowledges and accepts that neither the weather nor the results of the hunt are guaranteed. It is the policy of Rafter C that in the case of a wounded animal, all efforts to take and recover wounded animal will be used. The wounded animal may be determined to be considered a kill and the hunt is over for that hunter. Also, in the case of wounded or crippled livestock while hunting, we will try and replace or cure livestock for continued use. In this case, use of livestock may or may not be available at such a time or situation. Each hunter acknowledges and understands the terms of the hunt as stated in advertising material, web site, and correspondence, and booking contract, and agree to book on that basis. Both parties agree that this is a legal and binding contract.
